- Project Timeline: March June 2014

Did You Know? In 2014, Pueblo Arts Alliance successfully applied for a Colorado Garden Foundation grant in the amount of \$7,500 for irrigation and landscaping of Central Plaza. This money was used in conjunction with urban renewal funds to implement art in public spaces and concrete work.





Downtown Pedestrian Alleyways

- \$50,000
- Project Timeline: April-May 2014

Did You Know? In 2014, PURA and the City of Pueblo began Phase I of the Pedestrian Alleyway project by installing permeable brick pavers along the alleyway between Union and Victoria Avenue from the Riverwalk to D Street. Phase I also included private donations in the form of neon lighting on the opposite end of the alleyway between C and B Street.

Property Improvement Program

Former Police Department Building

- \$46,800 in the form of a loan
- \$11,700 in the form of a grant

Did You Know? As part of a major rehabilitation effort, PURA financed window replacement for this historical building located in the heart of downtown Pueblo.

Sharpy's Auto Pawn

- \$24,106 in the form of a loan
- \$6,027 in the form of a grant

Did You Know? In partnership with the business, located in the Historical Eastside, PURA helped finance façade improvements that included installation of stucco, concrete, paint, new doors and windows.

East 5th Street

\$9,922 in the form of a grant

Did You Know? In an effort to help revitalize the Eastside neighborhood, PURA financed tree removal and public improvements along East 5th St. that included sidewalk and water main repair at 824 E. 5th St.
